The Department of Health Policy, Management and Behavior in the Jiann-Ping Hsu College of Public Health (JPHCOPH) invites applications and nominations for the position of lecturer. This position is located on the Armstrong campus.

The MPH program has six emphasis areas: Biostatistics, Community Health, Environmental Health Sciences, Epidemiology, Health Policy & Management and Generalist. The Doctor of Public Health (DrPH) degree has emphases in Community Health Behavior and Education, Biostatistics, Epidemiology, and Public Health Leadership. The Department of Health Policy, Management and Behavior offers the BSPH in Health Education and Promotion, MPH in Community Health, MPH Generalist, MPH in Health Policy Management, DrPH in Community Health Behavior and Education and DrPH in Public Health Leadership.

<u>Position Description</u>. Reporting to the Department Chair, the Lecturer will be required to contribute to departmental and college teaching and services objectives. The position centers on strengthening the department's undergraduate course offerings and will include a workload of primarily teaching time in core curriculum courses, consisting of contact hours in the classroom and additional service associated with student success in the core curriculum. The successful candidate will also possess a commitment to innovative methods of instruction and professional development in the area of teaching. The position is a 9-month, non-tenure track appointment, and the salary is competitive and commensurate with qualifications and experience.

Required Qualifications:

- Earned Master's degree in Public Health or a closely related field by August 1, 2018.
- Commitment to teaching, academic program development, and service that is consistent with the College's vision and mission.
- Ability to contribute to a positive work environment in the College and the University.
- Must be authorized to work in the United States for the duration of employment without assistance from the institution

Preferred Qualifications:

- Necessary academic qualifications to teach introductory courses in the core public health curriculum.
- A minimum of 2 years, full-time college/university teaching experience.

Screening of applications begins January 21, 2019, and continues until April 19, 2019. The preferred position starting date is August 1, 2019. A complete application consists of a letter addressing the qualifications cited above; a curriculum vitae; and the names, addresses, telephone numbers, and email addresses of at least three professional references. Other documentation may be requested. Only complete applications and applications submitted electronically will be considered. Finalists will be required to submit to a background investigation.
